August 3, 2011

I. Addressing the suggestion at the league meeting to return to having a roster with names provided to refs for each game

*This was not working as teams would still have ladies come sub, and names would just be written on scorecards. And this does not happen as much in the fall with games being at the same times. (Always more of a problem in the Spring.)

- a. Provide a means for teams to petition for questions on team player's age or status on team.
- b. Do we have ladies provide ID's with waivers again?
- c. NOTES from meeting:
 - i. Not for Fall 2011, and we will not institute unless there are still issues this fall.
 - ii. If there are questions on the age of an opponent or the identification of a player (vs. the scorecard), the refs will mediate and ask to see the player's driver's license or a copy of the DL. (Team captains will be informed so they can notify players to have available at the field.)
 - iii. The board will inform team captains that we are going back to scorecards with the roster listed on them; any handwritten names on the scorecard will need an accompanying waiver to show to the ref on the field. The refs will be asked to hand in the waiver with the scorecard or give it to a board member.
- II. Request from teams to break into 3 divisions board reminded attendees that it would be best to have additional teams before adding back another division; Brandon from Back of Net – his wife is on a team from Oakland Academy, contact to see if they would like to join our league
 - a. I think the request was more for the top 2 teams from D2 to be moved up to D1. (request by Fletchers) Me and Elaine think if we move teams up they will get creamed in D1. The top 2 teams in D2 did not beat any team by a significant amount of goals in the Spring so we will not be moving any teams up.
 - Also, Oakland Academy was contacted at the beginning of Spring season. They could not gather enough players to form a team.
 Some of their players ended up combining with another team, not sure which one.
 We will NOT be doing 3 divisions for the fall 2011 season.
