
Dear Camper,

Special points of interest:

- **ELIGIBILITY:** Any boy ages 8-15 is eligible if he has not entered the 10th grade. Football skills will be taught on each campers level.
- **DRINKS:** Water and gator-aid will be provided during workouts, additional drinks may be purchased.
- **Discipline:** All camp rules will be presented and must be adhered to by all campers. Violation of rules will result in dismissal with no refund.
- **Location:** Terry Sanford athletic fields, located behind the school.
- **Equipment:** Each camper should bring tennis shoes and cleated football shoes. He should wear gym shorts, tee shirt and athletic socks.

Special points of interest:

- **CAMP SCHEDULE:** Check-In on Monday, July 27th, 5:00 - 6:00pm. Parents should schedule to pick up campers at 9:00pm.
- **INSURANCE AND MEDICAL CARE:** Your child's health and safety will be our first and foremost concern as an athletic trainer will be present at all times and medical facilities are only a few minutes away.
- **COST OF THE CAMP:**
 - \$60.00 - Per camper
 - \$50.00 - Group containing 7-10 campers
 - \$40.00 - Groups containing 11 or more campers
